* Teaching and learning activities for courses offered by the College are conducted by suitably qualified Fellows of the College.

General safety/maintenance of teaching and learning facilities:

The College ensures general safety and maintenance of its office and other sites used for teaching, learning and assessment.

The ACP Postgraduate Program is delivered fully online, with teaching, learning and assessment delivered via the College online platform. The College provides IT and website support for students year-round through the Executive Manager. Induction materials and guides are available to assist students with login and interaction with the online subjects.

The principal sites for the delivery of the Clinical Training Program which involves some face to face (F2F) teaching components may vary from year to year but always involve accredited hospitals and/or private practices. These sites, while being individually under the control of the various governing bodies and the State and Federal legislation under which they must operate, are accredited by the College in terms of their suitability to fulfil the teaching and learning requirements laid down by the various College programs as well as factors which impinge on a students' day to day participation in the program on a rotational basis.

In general, students participating in programs offered by the College are employees of the above mentioned institutions and as such are subject to the governance and other operational policies and procedures of those institutions in addition to those provided through the College where appropriate including those pertaining to but not limited to:

- Access to human resources
- Student support (including access to appropriate resources)
- Student safety and security
- Amenities (including teaching and study spaces, laboratory, research and recreational facilities).
